
# Court of Appeals of Virginia Statistical Review

**Introduction** Since the inception of the Court of Appeals (CAV) in 1985, case filings have increased from 1,641 to 2,104 in 2017, an increase of 28.2%. The highest recorded number of cases filed in the CAV (3,499) was in 2001. Between 2013 and 2017, there was a decrease of 14.9% of total cases filed. Petitions refused and cases disposed collectively have tripled since 1985 from 689 to 2,053. This caseload statistical review focuses on the caseload trends and types of case filings between 2013 and 2017 in the CAV.

**Cases Filed and Disposed** The table above (Table 1) shows an overview of the case filings for the CAV for the past five calendar years. In 2017, the CAV recorded 2,104 case filings, 20 less than the 2,124 in 2016 and 33 more than the 2,071 in 2013. Between 2016 and 2017, the decrease in cases filed was driven by decreases in criminal petitions and domestic relations case filings, as well as concealed weapons applications, appeals by the Commonwealth before the end of trials and civil contempt. Final dispositions totaled 2,056 in 2017, 96 less than the year before and 346 less than 2013. Of the final dispositions, 74.3% were criminal cases. Since 2013, criminal dispositions have decreased 14.2%, while non-criminal dispositions decreased 15.1%. During the five years, filings have decreased 14.9% and final dispositions have decreased 14.4%.



**Case Filings Mix** Between 2013 and 2017, the majority of the cases filed in the CAV consisted of criminal petitions, domestic relations, and Workers' Compensation Commission cases. In 2017, Worker's Compensation Commission cases increased by two cases filed or 2.2% since last year and decreased 104 cases filed or 53.1% since 2013. The percentage of criminal petitions in 2013 was 72.9%, which fell slightly to 72.4% in 2017. The combined percentage of domestic relations and Workers' Compensation Commission cases filed decreased from 18.1% of filings in 2013 to 15.5% in 2017.



**Criminal Petitions** Of the cases filed, criminal petitions including contempt constituted the majority of the filings, 73.1% in 2017. That same year, criminal petitions fell 1.1%; conversely, granted criminal petitions increased 4.2%, increasing from 192 in 2016 to 200 in 2017.

**Original Jurisdiction** In 2017, the total original jurisdiction cases filed was 40 which is four or 11.1% more than 2016, and two or 4.8% less than 2013. Between 2016 and 2017, the number of habeas corpus and actual innocence original jurisdiction case types increased.

**Appeals of Right** In 1985, there were 538 appeals of right and in 2015, there were 501, a decrease of 6.9%. In 2017, there was an increase of 1.5% from 2016 and a decrease 13.5% from 2013 for total appeals of right filings. While Workers' Compensation Commission cases had continued to experience decreases between 2013 and 2016, there was a 2.2% increase since last year. The "other" category that includes concealed weapons applications and civil contempt cases decreased in 2017 by 33.3%.

**Disposition of Appeals** In 1986, the first year detailed disposition data was provided in the State of the Judiciary Report, there were 328 cases involving appeals of right or granted criminal appeals decided by opinion and 386 cases decided by order. Each of the 10 judges averaged 33 opinions and 39 orders, an average of 71 dispositions per judge. In 2017 with 11 judges, the average disposition per judge (61) was below the 1986 average. There was an average of 31 opinions per judge and 31 orders per judge in 2017 with the total disposition of appeals being constituted of approximately half opinions and half orders.
